- Motion: The Specialty Show Coordinator, charged with updating an approved judges list every three years, shall enlist the assistance of two additional members of the Specialty Show Committee to conduct the count. Upon completion of the tabulation of those AKC judges in the top 15%, the coordinator will promptly share the following information with the committee, the NCA Board and be published in the next issue of *Newf Tide*.: This information is of legitimate interest to our members who show and breed.
 - Number of NCA members who voted
 - Number of votes judges needed to qualify to be on the list
 - Number of votes each judge received

Rationale: Board election procedures (see policy manual, p.47) provide pattern of transparency for elections conducted by the NCA. (Jacqueline Brellochs)
- Motion: Pam Rubio, Lynne Anderson-Powell, Kathy McIver, John Cornell and Pam Saunders move that the 'Committee' articles be administered with respect to *Newf Tide* Policy Committee's general policy on article submissions and not as a committee report.

NEWF TIDE POLICY COMMITTEE

The Newf Tide Policy Committee requests that the board consider adopting the following change in the policy governing regional club submissions to *Newf Tide*:

Presently the policy reads that “each regional club may submit two club columns per year in the appropriate quarters.”

Proposed change in bold: “Each regional club may submit two club columns per year **in any quarter**. Rest of policy to remain in full force and effect: Columns are limited to 250 words and are intended to promote communication of interesting projects and activities across the country.

Rationale: Giving clubs the option of submitting a column in any quarter may have a more positive impact upon submissions.

Vote: This change was a unanimous decision of the four members present at the meeting on 8/10/10: Jeannette Voss, Beth Sell, Patti Emmerling, Aura Dean (Editor, Meredith Reggie, ex officio, present, but not voting; absent: Ken Wildman and Julie P. Siefert.)

Good afternoon Lori.

The committee discussion on your proposal Thursday night was very good. The consensus of the committee was that a subcommittee would be a better approach than an ad hoc committee, or that possibly there should be a separate committee to review and maintain NCA documents. The latter, given the interest in reducing the number of committees, may not be the best option. It was also discussed that the role of this ad hoc or subcommittee should be that of a liaisonship between those committees who tend to share each other's work (documents), and should include a Gen Ed liaison since a lot of the educational documents will be managed through that committee. This would allow good collaboration between the committees whose goals and perspectives differ but whose activities sometimes overlap. As we've discussed in the past, the differences between the committees may allow some readers to better relate to the different documents and formats arising from the work of those committees. In simpler terms, we feel that our readership is not a one-size-fits-all group.

It was also suggested that volunteers could be used to update specific documents, and that it may be easier to get individual volunteers who would be willing to make short commitments for specific purposes, which could foster a shorter timeline to completion.

In general, there was strong consensus among the committee members that this would be a good way to handle this project, for you to chair a separate committee or subcommittee to see this project through to its completion. The potential committee members you have identified (Pam Rubio, Meredith Reggie, Kathy McIver, Mary Lou Roberts and Marylou Zimmerman) along with a Gen Ed representative would provide a cross-functional group and include some very good writing/editing talent.
